



# OFFICIAL WARNING LETTER

**ONLINE HARASSMENT - BLACKMAIL - CYBERBULLYING - HATE SPEECH - PRIVACY VIOLATIONS - CHILD SAFETY CONCERNS**

**WARNING NOTICE BEFORE ACTION: You are formally instructed to remove harmful content, stop abusive conduct, and correct the issue immediately before Somali Unity Shield proceeds with platform reporting, takedown requests, evidence escalation, or other appropriate action.**

## 1. PURPOSE OF THIS WARNING

This letter is issued by Somali Unity Shield (SUS), Digital Safety & Community Protection Division, as a formal warning before further action. The purpose of this notice is to educate, document, and provide an immediate opportunity to stop harmful online conduct before escalation is taken.

This warning concerns reported online behavior involving harassment, public humiliation, intimidation, blackmail, hate speech, privacy violations, unauthorized posting of private information, and the possible exposure of children, families, women, vulnerable individuals, or private persons on social media platforms and livestream environments.

## 2. CONDUCT REPORTED

1. Posting or sharing private photos, videos, recordings, personal details, family information, or private communications without consent.
2. Using social media, livestreams, comments, direct messages, or group chats to insult, threaten, humiliate, intimidate, harass, or shame another person.
3. Blackmailing, pressuring, or threatening individuals by using screenshots, recordings, private images, edited clips, rumors, or personal information.
4. Publishing or exposing children, family members, spouses, relatives, vulnerable individuals, or private homes without authorization.
5. Encouraging others to attack, mock, target, bully, mass-report, or publicly shame a person or family.
6. Spreading false allegations, hate speech, clan-based hostility, discriminatory abuse, or harmful accusations that may place people at risk.

## 3. REQUIRED IMMEDIATE ACTIONS

1. Remove all harmful videos, photos, posts, livestream clips, comments, screenshots, recordings, or reposts immediately.
2. Stop all harassment, threats, blackmail, intimidation, humiliation, insults, and abusive livestream behavior.
3. Do not publish, repost, save, circulate, or encourage others to circulate private content involving any person, family, child, or vulnerable individual.

4. Do not contact, threaten, pressure, or retaliate against the person who made a report or anyone connected to the matter.
5. Preserve relevant evidence. Do not delete evidence for the purpose of hiding wrongdoing, but remove public harmful content from public view immediately.
6. Provide proof of takedown or correction if requested by the affected person, platform, authority, or Somali Unity Shield review team.

#### 4. WHY THIS MATTER IS SERIOUS

Online abuse can cause severe harm to a person's safety, reputation, privacy, family life, education, employment, emotional wellbeing, and community standing. Publicly exposing private content, using children or family members as weapons in online conflict, or threatening people through social media is not acceptable and may violate platform rules, privacy laws, child safety standards, cyberbullying policies, anti-harassment laws, and other applicable civil or criminal rules depending on the country and facts involved.

**Somali Unity Shield's approach is protection, prevention, education, and responsible escalation. This letter is not a court order. It is a formal community protection warning and notice before further reporting or escalation may be considered.**

#### 5. FAILURE TO COMPLY MAY RESULT IN

1. Formal reports to TikTok, Facebook, Instagram, YouTube, WhatsApp, Telegram, or other relevant platform safety teams.
2. Takedown reports for harassment, bullying, hate speech, privacy violation, child safety concerns, impersonation, blackmail, or unauthorized private content.
3. Evidence packets prepared for digital safety organizations, child protection agencies, legal representatives, law enforcement, or other appropriate authorities where applicable.
4. Requests for account restrictions, content removal, suspension, permanent ban, monetization review, livestream access review, or other platform enforcement action.
5. Further documentation of repeat behavior, retaliation, threats, or continued online abuse after this warning has been delivered.

#### 6. NO RETALIATION NOTICE

Any attempt to retaliate, threaten, expose, insult, blackmail, or pressure the reporting person, witnesses, family members, children, or Somali Unity Shield representatives may be treated as additional evidence of continued harmful conduct and may be included in any escalation file.

#### 7. COMPLIANCE DEADLINE

Immediate action is required. Harmful public content should be removed without delay. Continued posting, reposting, threats, livestream abuse, or public humiliation after receipt of this notice may be documented as failure to comply.

### 1. UJEEDDADA WARQADDAN

Warqaddan waxaa soo saartay Somali Unity Shield (SUS), Digital Safety & Community Protection Division, iyadoo ah digniin rasmi ah ka hor inta aan la qaadin tallaabooyin kale. Ujeeddadu waa wacyigelin, diiwaangelin, iyo in fursad degdeg ah lagu siiyo qofka ama kooxda lagu eedeeyay inay joojiyaan dhibaataada online-ka.

Digniintan waxay khusaysaa warbixino la helay oo ku saabsan dhibaataayn online ah, ceebayn dadweyne, cabsi gelin, blackmail, nacayb, xadgudub sir ah, faafinta xog gaar ah, iyo suurtagalnimada in carruur, qoysas, haween, ama dad nugul lagu soo bandhigay baraha bulshada ama livestreams iyada oo aan oggolaansho jirin.

### 2. FALALKA LA SOO SHEEGAY

1. Faafinta ama soo gelinta sawirro, muuqaallo, codad, xog gaar ah, xog qoys, ama wada-sheekaysi gaar ah iyada oo aan oggolaansho jirin.
2. Isticmaalka baraha bulshada, live-ka, comments, fariimo gaar ah, ama groups si qof loo caayo, loo handado, loo bahdilo, ama loo cabsi geliyo.
3. Blackmail, cadaadis, ama hanjabaad lagu sameeyo iyadoo la adeegsanayo screenshots, recordings, sawirro gaar ah, muuqaallo la jarjaray, warar, ama xog shakhsi ah.
4. Soo bandhigidda carruur, xubno qoys, lamaane, qaraabo, dad nugul, ama guryo gaar ah iyada oo aan fasax jirin.
5. Kicinta dad kale si ay qof u weeraraan, u caayaan, u bahdilaan, ama si wadajir ah ugu sameeyaan bullying online ah.
6. Faafinta eedeymo been ah, hadal naceyb ah, qabyaalad, ama aflagaado khatar gelin karta qof ama qoys.

### 3. TALLAABOYINKA DEGDEGGA AH EE LAGA RABO

1. In si degdeg ah loo tirtiro dhammaan muuqaallada, sawirrada, qoraallada, livestream clips, comments, screenshots, recordings, ama reposts-ka waxyeellada leh.
2. In la joojiyo dhammaan dhibaataaynta, hanjabaadda, blackmail-ka, cabsi gelinta, ceebaynta, aflagaadada, iyo abuse-ka live-ka.
3. In aan la daabicin, dib loo faafin, la kaydin, ama dadka kale lagu dhiirigelin in ay faafiyaan waxyaabo gaar ah oo khuseeya qof, qoys, carruur, ama qof nugul.
4. In aan la hanjabin, la cadaadin, ama laga aargudan qofka warbixinta sameeyay ama qof kasta oo arrintan la xiriira.
5. In caddaymaha muhiimka ah aan loo tirtirin si loo qariyo fal khaldan, laakiin waxyaabaha waxyeellada leh ee public-ka ah si degdeg ah looga saaro dadka hortooda.

3. Diyaarinta evidence packets loo gudbin karo digital safety organizations, child protection agencies, legal representatives, law enforcement, ama hay'adaha ku habboon marka ay khuseyso.
4. Codsii ku saabsan xaddidaad account, content removal, suspension, permanent ban, monetization review, livestream access review, ama enforcement action kale oo platform-ku qaadi karo.
5. Diiwaangelinta falal soo noqnoqda, aargudasho, hanjabaad, ama continued online abuse kadib marka digniintan la helo.

#### 6. OGEYSIIS KA DHAN AH AARGUDASHO

Haddii qof isku dayo inuu u aarguto, u hanjabo, soo bandhigo, caayo, blackmail gareeyo, ama cadaadis saaro qofka warbixinta sameeyay, markhaatiyaasha, qoyska, carruurta, ama xubnaha Somali Unity Shield, arrintaas waxaa loo qaadan karaa caddayn dheeraad ah oo muujinaysa in dhibaataadii weli socoto.

#### 7. XILLIGA FULINTA
